COUNTY AND STATE CONVENTIONS

This year there has been a significant crop of energetic new delegates at the conventions who have put in MANY hours vetting county and state candidates in personal meetings and coordinated Internet Zoom calls. Despite some setbacks, the new delegates felt we had made some progress in standing up for Conservatism and for Liberty, rather than caving into the demands of the Progressive Left. Your Precinct Chair managed to pick up a vacant state delegate position during the county convention.

The party generally agrees that the law that came out of SB54 is a major problem. It allows political candidates to collect signatures to get on the ballot. This somewhat circumvents the convention process, and some of the scrutiny and vetting to which they would otherwise be subjected.

The Progressive Left is working to infiltrate the GOP. They re-register as Republican. (As one operative stated, doing this is “a strategy, not an identity.”) Not only do they grab precinct positions, but they also run for office as Republicans.

GOP PRIMARY

The Utah GOP primary is June 28, and ballots are being mailed out the first week of June. **Please do NOT throw your ballot away and skip voting in the primary. Your voting participation is desperately needed in June, and again in November.**

The following candidates are official convention winners. Due to signature gathering allowed under SB54, they will face opponents in the primary. Please give the official winners your support! Our website has more information about the primary.

SLCO GOP 2020 ELECTION AUDIT COMMITTEE FINDINGS

Our county GOP conducted an investigation on county data from the 2020 election. Despite working with a highly restricted set of data, and a general lack of cooperation from election officials, the audit committee discovered disturbing chain of custody gaps in ballot handling. Based on the committee's recommendations on "safe" voting, this is my suggestion for you in order from safest to least safe: 1) vote in person at the polling place (River Bend Senior Center); 2) drop off the mail-in ballot on Election Day; 3) place mail-in ballot in the drop box (River Bend Senior Center) on Election Day, not before.

Once your ballot enters the USPS mail system, chain of custody is corrupted.
