Election Day is November 8. Please vote on that day!

"The midterms aren't important."

"The system is rigged so my vote won't make a difference."

Yes, your vote does matter. Even if the system is rigged. Even if the election outcome is not what you want. Skilled investigators are working night and day analyzing our elections. When we vote, we also provide data for statistical review – without sacrificing ballot privacy.

The following safe voting practices are listed, starting with the best:

- 1) Vote IN PERSON at River's Bend Senior Center **on November 8, not before.** (Bonus Tip: Take a cell phone picture of your machine receipt.)
- 2) Drop your completed and sealed mail-in ballot off IN PERSON at the Senior Center **on November 8, not before.**
- 3) Place your completed and sealed mail-in ballot in the drop box at the Senior Center **on November 8, not before.**

Mailing your ballot may break chain-of-custody. Voting on Election Day minimizes the time your ballot can be handled. These three ballot delivery methods maintain chain-of-custody **and** minimize ballot handling time.

The strength of our constitutional republic starts with a secure, **transparent** election process with **accountability** that deserves the confidence of its voters.

Goud Maragani is a compliance attorney. He has the skills to track an organization's efforts to adhere to policy and to law. He is able to design and implement efficient, **transparent** procedures to help organizations do so. Goud wants to vigorously ensure voter rolls are accurate, and he wants poll watchers to be able to pre-schedule their work.

Without full access to 2020 county election data, Goud nevertheless managed to conduct a review that drew many useful conclusions on improving our process. For example, he recommends:

- two factor identification on mail-in ballots – signature plus ID (as signature verification falls short)
- the same deadline for all ballots submitted by voters from within Utah, no matter how delivered – namely, close of polls on Election Night.

From his results, he came up with safe voting recommendations, which are customized for our precinct on page 2.
